In 2017, Austin Pets Alive! experienced a truly unprecedented year, in more ways than one. This has left us with a significant rise in assets, most of which are restricted to specific uses and cannot apply to our usual annual operations at APA!.

Our Hurricane Harvey work resulted in nearly \$5 million pouring in from supporters all across the country, and even the world. In the months following Hurricane Harvey, we spent over \$970,000 on our efforts in Houston and its surrounding areas. We must continue honoring our donors' wishes by using the Hurricane Harvey funds to increase lifesaving over the next few years by helping the animals from the coastal areas that are still in need of support.

Additionally, thanks to a generous \$4 million multi-year grant from Maddie's Fund, we have successfully launched the Maddie's Lifesaving Academy. Through collaboration with Maddie's Fund and Austin Animal Center, we are teaching communities across the country our innovative lifesaving programs. By the end of 2018, we will have hosted over 500 students from communities all over the country and will host even more students in the coming years. All academy costs are covered by this external funding, while we continue to save the lives of thousands of Central Texas' most vulnerable animals with the help of our amazing community of donors, volunteers, fosters and adopters.

We are truly grateful for the support that we have received throughout 2017. However, we still need to raise our annual operating funds to support our lifesaving work for the thousands of vulnerable animals that need us the most in Central Texas. Our work to keep Austin the largest No Kill city in the country is constant, and only continues to be possible because of the support of our whole community – adopters, fosters, volunteers, and donors. The funds we raise each year during the holiday season set us up for success in the year ahead and save thousands of lives in the coming year.
