

Monthly Report on License Agreement 2023-03 March

This report is in agreement with the terms outlined in Section 8.4 of the License Agreement between the City of Austin and Austin Pets Alive! with a focus on APA!'s impact on Travis county through our partnership with Austin Animal Center.

Summary: Austin Pets Alive! (APA!) continues to be the city of Austin's largest partner in lifesaving. APA! takes animals that have medical and behavioral issues that require a higher cost per animal than the average healthy animal in care. APA! focuses on these animals in an effort to have a measurable effect on the live release rate at AAC.

APA! Intakes transferred from AAC:

180 animals were transferred out of AAC to rescue partners in March. 121, or 67%, of those were transferred to APA!

18 animals were born in APA!'s care to pregnant animals sent from AAC. Additionally, APA! took in 33 pets directly from owners within Travis county through the PASS program that should have otherwise entered AAC. This makes for a total of 51 intakes diverted from AAC.

Fiscal Year 2023, Q2 Summary

Austin Animal Center reported 2,377 intakes from Jan-March 2023. 282 animals, or 11.9% of intakes, were transferred to APA! in that time. Almost half (130) of those were urgent/immediate transfers with 2-hour deadlines.

APA! directly diverted 202 animals from entering the city shelter system. This number includes surrender intakes from Travis County via the PASS Program and animals born in APA!'s care to moms from AAC.

All AAC-attributed intakes (transfers and born-in-care to AAC moms) combine to make up over 18% of APA!'s overall shelter intake. AAC continues to be the largest sending partner of APA!.

APA!'s current TLAC shelter population includes 24 cats and 96 dogs originally from AAC or born to moms from AAC. This is 34% of the overall TLAC population. In addition, there are about 250 AAC animals currently in APA! foster homes, including over 150 dogs.

This quarter saw the highest number of dog medical case transfers in the past year with 65 total. This was a 65% increase over the previous quarter (39 total).

March saw the start of kitten season, with a notable increase in bottle baby transfers compared to the prior six months. The highest bottle baby transfer months of 2022 were May and June, so we are anticipating that transfers will continue to increase over the next few months.

APA!'s behavior team continues to work with the AAC team to prioritize dogs needing advanced behavior support for evaluation and transfer. In this quarter, APA! took custody of 18 behavior dogs from AAC, including 2 small dogs.

Of those 18, 4 are adoptive homes, 2 are in foster, and 12 are at TLAC.
